HR 165 REPORT OVERVIEW

 To review wage and contracted rates for care staff in Home/Community-Based Services (HCBS).



2. To determine staffing levels needed by HCBS providers, including staff members with specific expertise or certification.

Section III Findings:

- 1. There is no government data that specifically tracks the home and community-based workforce in Pennsylvania.
- 2. Demand for home and community-based services is expected to continue to grow in Pennsylvania, further exacerbating the direct care worker shortage.

Section IV Findings:

- 1. During our review period, the Community HealthChoices and Omnibus Reconciliation Act waiver programs' enrollment and expenditures increased, and the Act 150 program enrollment and expenditures decreased.
- 2. During our review period, the Office of Long-Term Living Home and Community-Based Waiver Service fee schedule rates for personal assistance services increased by 10 percent. However, respite services rates did not change during the same period.
- 3. The Office of Long-Term Living is not required to review rates or conduct a rate study on a set timeline, unlike the Office of Developmental Programs, which must review rates at least every three years.



Section V Findings:

- Direct support professionals are not tracked as an occupation in state and federal data.
- 2. During our review period, average direct support professional wages in Pennsylvania kept pace with the national consumer price index but were lower than in surrounding states (with available data).
- 3. During our review period, the direct support professional workforce faced higher vacancies than other Pennsylvania economic sectors.
- 4. While the Department of Human Services has worked to reduce the Office of Developmental Programs waiting lists, more individuals are waiting for services than there are resources available.



RECOMMENDATIONS



As a result of the report's findings, we made a total of seven recommendations.

RECOMMENDATIONS OVERVIEW

The Departments of Labor and Industry, Human Services, and Aging:

Absent the federal government changing workforce data collection to address the HCBS workforce at large, the above departments should collect data about the Pennsylvania HCBS workforce for rate setting, budget decisions, and other public policy considerations. This data should include tracking DSPs as a separate occupation.

The General Assembly should consider:

- Require a performance audit to evaluate the Direct Care Worker Job Quality Grants, steps taken to reduce waiting lists (after the COVID-19 pandemic and the American Rescue Plan Act of 2021 funding), and the effectiveness of additional OPTIONS funding (\$5 million beginning in FY 2023-24).
- Inflation adjustments to HCBS state-directed rates, including a required amount that must go directly to direct care workers.
- Working with DHS on reducing the Office of Developmental Programs' waiting lists, and appropriate Office
 of Long-Term Living HCBS funding levels.

The Department of Human Services should consider:

Changing its regulation to require a periodic review of the Office of Long-Term Living's HCBS rates.
